NOTICE INVITING E-TENDERS FOR HIRING OF VEHICLE ON CALL BASIS FOR IIPMB

E-Tenders are invited from reputed service providers for the hiring of vehicles for use by Indian Institute of Plantation Management, Jnana Bharathi Campus, Post. Mallathahalli, Bengaluru – 560 056, (hereinafter also referred as 'the hirer') for the current financial year i.e., for period of One year (or shorter period as may be decided by hirer).

Interested parties may submit their bids for providing services based on call basis. The
quotations should be submitted as per two bid system i.e. Technical and Financial bid
which should be submitted separately. These shall be super-scribed "FINANCIAL BID"
and "TECHNICAL BID", "TENDER FOR HIRING OF VEHICLE-Bus".

FINANCIAL BID: Rates shall be quoted separately for AC & Non-AC vehicles in the column provided in Annexure – B. The rates shall be exclusive of Taxes /Toll Charges / Parking charges / State Permits charges other statutory charges.

- 2. The tender shall be submitted on or before 29.12.2025 15:00 Hrs through e-tendering mode. The Tender will be opened on 29.12.2025 16:00 Hrs.
- The applicants who wish to be present at the time of opening of the Tenders may do so themselves or through their authorized representative at the appointed date and time.
- 4. The Financial Bids of only those bidders shall be opened, whose Technical Bids are qualified. The format of the technical bid and financial bid is enclosed as Annexure-A and Annexure-B.

1. The terms and conditions of the Tender are as under:

- a) The rate quoted should be for a commercially registered vehicle that is new or up to 5 years old and without any accident history, in excellent and neat exterior, interior and running condition and the same should also be maintained during period of hire.
- b) The vehicle shall be provided on any day including Saturday, Sunday and Holidays, if required by the hirer. No extra payment will be made for providing the vehicle on Saturday, Sunday or holidays;
- c) Zero based mileage i.e. mileage starting and ending at/from duty or drop off location shall be adopted for the purposes of calculating the kilo meters.
- d) The bidder should have arrangements for establishing contact and round the clock service.
- e) The bidder should be registered with the Service Tax/GST (if applicable). Department and hold PAN. Service Tax/GST will not be reimbursed, if the Service Provider fails to produce proof of payment of Service Tax/GST.
- f) On completion of travel, the vendor may submit the bills for payment along with all required payment receipts like toll fare, parking charges, permits etc., other if applicable. The bills shall be paid in 5 working days.
- g) The vehicle provided should comply with laws in force in India.
- h) The driver should have valid driving license and comply with all the relevant laws in force and he should be adequately experienced, and maintain decency, politeness, neat dress and good habits.
- i) The driver should be equipped with a functional mobile phone at the bidder's cost, for contact purposes. Driver should be well versed with the routes and locations in entire Bengaluru, its surrounding areas & other states in case interstate journey. Driver/service provider shall maintain logbook with vehicle indicating the day to day running mileage.
- j) Once hired, the vehicle will not be put to use for any other purpose, and the vehicle and driver will work under the overall supervision of IIPMB.
- k) In order to ensure day to day functionality of hirer, once hired, service provider shall not keep changing or rotating vehicle and driver, except if the hirer so indicates in case of any eventuality or unsuitability.
- I) The bidder will comply with labour laws in force and all liabilities in this connection will be his.
- m) If the contract is awarded, the bidder will provide to IIPMB, the complete details of vehicles, certified copies of the RC books, comprehensive insurance policies

- as well as full details of deployed driver, his address, and copy of his driving license.
- n) IIPMB will not be under any obligation, legal or otherwise, to provide employment to any of the personnel of the service provider during or after the expiry of the hire period. IIPMB recognizes no employer-employee relationship between IIPMB and the personnel deployed by the service provider. IIPMB shall not be responsible financially or otherwise for any injury to the vehicle or driver or person deployed by the service provider during the course of hire.
- o) In case of any accident, any and all the claims and damages arising there from shall be met by the service provider.
- p) The service provider shall undertake to indemnify IIPMB against all damages/charges arising on account of or connected with the negligence of the service provider or his staff or any person under his control whether in respect of accident/injury to the person or damages to the property of any member of the public or any person or in executing the work or otherwise and against all claims and demand thereof.
- q) In the event of the hired vehicle developing snags, the service provider will ensure that a replacement vehicle is provided on priority and in case of failure to make alternative arrangement, IIPMB will be at liberty to hire other vehicle and the cost incurred on account of such hiring shall be at the expense of the service provider.
- r) IIPMB reserves the right to charge penalty, Rs.1000 per hour of delay for non-provision of vehicle in time/breakdown, and Rs.1000 per instance of misbehaviour of driver.
- s) IIPMB reserves the right to terminate the contract without assigning any reason by giving two days' notice.
- t) IIPMB shall not make any advance payments and payments shall be made only on the basis of monthly bills submitted by the 5th of the succeeding month.
- u) The Director, Indian Institute of Plantation Management, Bengaluru, reserves the right to require fulfilment of other conditions, not expressly mentioned, which are consistent with use of vehicles on hire with this office, and to reject any or all tenders without assigning any reason there for.
- v) The Director IIPMB reserves all rights to reject any tender including of those renderers who fail to comply with the instruction without assigning any reason whatsoever and does not bind itself to accept the lowest or any specific tender. In case of dispute, the decision of the Director, Indian Institute of Plantation

Management, Jnana Bharathi Campus, Post. Mallathahalli, Bengaluru – 560 056, shall be final and binding.

- w) Joint ventures/Consortium bids are not allowed
- x) The contract shall commence from the date of consent of the firm to terms and the Conditions. To begin with, the contract will be for one year initially may be extended on yearly basis if performance/service is found satisfactory on review after every six months. The contract so awarded can be terminated at any time by giving **one month notice**.
- y) EMD of Rs.24,000.00 should furnish along with the bid, EMD will be forfeited in case refuse to accept/sing work order or agreement.
- z) Performance Guarantee: 5% of the total value of tender (tender value Approximately Rs. 12 lakh) of the contracted work as performance Guarantee shall be paid by the successful bidder by way of Bank Guarantee/ Bankers Cheque/Demand Draft drawn in favour of Director, Indian Institute of Plantation Management, Bengaluru 560 056 within 7 days from the acceptance of contract. The earnest money Deposit of the successful firm shall be refunded after receipt of Performance Guarantee.
- aa) Financial bids of only those bidders will be opened who are technically qualified

- (2) Average Annual Turnover last 3 financial years Rs. 3.6 Lakhs (duly certified by CA)
- (3) Experience Criteria:

The bidder should have similar Work experience Any State/Central/PSU/reputed MNCs. The Bidder shall have successfully completed Similar Works during last 7 (Seven) years ending last day of month previous to the one in which tenders are invited should be either of the following:
